

# ENTERTAINMENT DANCE COMPANY 2021-22 SEASON CONTRACT

**EDC Season Contract:** The Entertainment Dance Company, hereafter referred to as “EDC,” 2021-2022 season contract will be in effect as of September 1<sup>st</sup>, 2021. This is a mandatory contract which must be read and the online registration form/liability waiver must be check marked, signed, and submitted online before your child(ren) may participate in any EDC instructional dance and/or tumbling classes.

**Enrollment Fee:** When enrolling for the new season, please remit the \$15.00 enrollment fee (per student) to reserve your child’s spot in class. Enrollment fee may be paid online through PayPal, Google Pay, or you may send a check to PO Box 96, Nortonville, Ks 66060. You may submit cash payment at the dance studio during our designated *Dancewear Order Times (TBA)*. Enrollment fee must be received by September 1<sup>st</sup> or the student may be dropped from the roster.

**Tuition:** Tuition is charged per month, not per lesson. Monthly tuition is due between the 1<sup>st</sup> and 15<sup>th</sup> of each month, after the 15<sup>th</sup> a \$10.00 late fee will be applied to the students account. If monthly tuition is overdue by 30 days or more, a \$20.00 late fee will be accessed. There is a \$30.00 fee for all return checks. No tuition refunds will be given for students who do not attend classes for which they have enrolled and/or paid for. EDC will except payment in the form of cash, check, PayPal, or Google Pay. When paying via PayPal or Google Pay, any and all additional fees which PayPal and Google Pay assess are the responsibility of the customer. All cash must be submitted with an envelope that states the students name, payment amount, and date. EDC is not responsible for cash which is not accounted for. You must have an original receipt issued by the dance studio to dispute any cash payments. Students with outstanding accounts will not be admitted to class and will not be eligible to participate in studio events. Late statements for tuition and other goods will be noted in the online *Parent Portal*.

**\*All solo and duo/trio spots are offered to competitive dancers on an audition basis. There are no recreational solo/duo/trio spots available for the 2021-2022 season.**

**NEW Online Registration:** Student enrollment will be accepted online through our registration system located on the "Enrollment" page of our studio website [www.edcdance.com](http://www.edcdance.com). Each parent/guardian will be required to set up their individual *Parent Portal* through the registration process.

**Annual Spring Dance Recital:** All dance students (ages 3-18) will be featured in our Spring Dance Recital. The mandatory Spring Recital dress rehearsal and Spring Recital are tentatively set for Thursday, June 2<sup>nd</sup> and Saturday, June 4<sup>th</sup>, 2022. Once a rehearsal/recital venue contract has been signed, we will announce the confirmed dates in January 2022. Both dress rehearsal and the Spring recital, are tentatively planned, to be held at Lansing Middle School auditorium. Due to rising cost of producing a recital each season, there is a \$40.00 recital fee per dancer due on or before June 1, 2022. \$5.00 of your recital fee will include access to all professional group portraits taken by Engelken Photography. The online gallery will be available for you to download and print (best quality up to a size 5X7) your students group team portraits. A print release will be available, in the gallery, for your convenience.

**Spring Recital Dance Costume Order (Dance Students Only):** Dance & Creative Movement students will be required to purchase a costume for each routine (class) they are enrolled in. Students will be measured in classes by Miss Jennie or Miss Marah during the first full week in October. Miss Jennie will choose students size based on the student's measurements and will contact parents with any size questions/concerns. Costume invoices will be available to view in your online *Parent Portal*. Costume fees cannot be refunded. Costumes must be paid in full and tuition accounts must be current before a student's costume order will be placed. Costume order dates take place in early October 2021 to ensure a timely delivery for all events. Parents and students will be notified of specific ordering procedure's closer to the event. Costume alterations, if needed, are the responsibility of the parent/guardian. There is a \$10.00 re-stocking/shipping fee on each costume that has to be size exchanged. Student's will also need to purchase proper shoes, tights, and possibly accessories and/or props which will be up to the director's discretion.

**Tumbling Showcase:** All tumbling students will be featured in our Spring Tumbling Showcase. Tumbling Showcase is tentatively set for May 27<sup>th</sup>, 2022. This event will be held at one of our local school gymnasiums. There will be a \$10.00 Showcase fee per student due on or before May 1<sup>st</sup> 2022.

**Tumbling Showcase Leotard Order (Tumbling Students Only):** Tumbling students will be required to purchase a tumbling performance leotard. Students will be measured in classes by Miss Jennie during the first full week in January. Miss Jennie will choose students size based on the student's measurements and will contact parents with any size questions/concerns. Leotard invoices will be available to view in your online *Parent Portal*. Leotard fees cannot be refunded. Leotards must be paid in full and tuition accounts must be current before a student's leotard order will be placed. This leotard is used each season and not required to buy new if current one still fits. Gently used team leotards are available to purchase; sizes and availability vary and is not guaranteed. Gently used leotards are sold on a first-come-first-serve basis.

**Class Age Eligibility:** Be sure to follow the age guidelines for classes to ensure appropriate class placement. A student must be 3 years of age on or before October 31<sup>st</sup>, 2021 for *Creative Movement* dance/tumbling class, unless otherwise approved by the director. Students must be 5 years of age on or before October 31<sup>st</sup> to participate in tumbling and the dance styles of jazz, tap, ballet, baton, pom, hip hop, and ribbon dance. Students must be 10 years of age and/or a level 5+ dance student for the style of lyrical and/or contemporary. Students must be 13 years of age to be eligible for the style of pointe ballet.

**Classical Ballet Class (Wed. 5:15pm):** Students may choose whether to dance en pointe or in a soft ballet slipper.

**Attendance & Studio Policies:** Students are expected to attend classes regularly. Attendance is key to student's success in class, Spring Recital, and/or Tumbling Showcase. Students are allowed to miss eight (8) hours of each class before they become ineligible to perform in the Spring Dance Recital and/or Spring Tumbling Showcase. Please notify the studio when your student will be absent. Do not drop a student off more than 10 minutes prior to class starting and be sure to pick them up promptly. Do not leave children at the studio while other classes are being taught as we are unable to provide proper supervision. Students are required to stay inside the building; teachers cannot monitor the safety of a child that is outside the studio. Parents must accompany their children when outside the building. EDC reserves the right to dismiss any student whose attitude, attendance, and/or

conduct is found unsatisfactory. If a student needs to schedule a “make-up” class due to being absent, a \$10.00 fee will be added to the student’s tuition account for each additional class scheduled.

**Class Attire:** Proper dancewear and shoes are required for the safety and success of each student and class.

Tumbling students will go barefoot and NOT need any shoes; absolutely no footed tights or socks. All female students should wear a leotard, fitted tank top, bra top (if approved by a parent/guardian,) dance pants, fitted shorts, and skirts. No skirts for tumbling students. Male students should wear pants, shorts, tank, or other styles of fitted tops. Make sure dance pants are not too long, pants that are too long or clothing that is too loose become a danger to students and staff. Students are not to wear baggy clothing items such as oversized t-shirts and athletic shorts. No blue jeans or jean shorts allowed. Jewelry is not allowed, as it can be a danger to your student and others. Hair MUST be pulled back away from face. Students are not allowed to wear their dance shoes as street shoes, this shortens the life of your investment and they cannot be worn on our professional dance floor. Please put your name on shoes and all other belongings. Please check our “Lost & Found” box for missing items.

**Observing A Class:** The studio policies for observing classes are located in the lobby and downstairs waiting room. These policies have been set to ensure that parents experience a pleasant wait during their student’s class and that students benefit as much as possible during their classes without any distractions. There are to be absolutely no parents, siblings, or friends in the class space at any time. Upstairs classes may be observed through our safety glass viewing window. Downstairs class may be viewed through the doorway. The last class of each month, parents will be invited in the classroom space (last 5-10 minutes of class) to see what our students have been learning. Those who fail to follow studio policies will be asked to leave the building. Requirement for visitors to wear masks while inside the building is up to the owner’s discretion and local/state health department policies. *\*Parent Watch Week will depend on any health recommendations/restrictions due to COVID-19.*

**Snacks & Water Bottles:** Students who attend two or more classes are welcome to bring a light snack. Only water will be permitted in the dance studio. Soda, juice, and other sugary drinks are NOT allowed in the building. This is to preserve the integrity of our studio as well as keep students’ personal items from damage.

**Main Studio Dance Floor:** EDC was thrilled to install a brand new professional non-slip *Harlequin* dance floor in 2014. This was a very expensive and valuable investment for our studio. There are to be ABSOLUTELY NO street shoes ANYWHERE on this dance floor, this includes flip flops!

**Acrobatic/Tumbling Moves & Lifts:** EDC and its staff are not held liable for any student who is injured while performing an acrobatic-tumbling move and/or lift-tricks. Students who performed such moves may be required to sign an additional liability waiver.

**Student Health:** EDC must be notified if a student has any medical needs or medication that may arise or need to be administered while at the studio. For the purpose of birthday treats and class holiday parties, please notify the studio of any food allergies or dietary restrictions. Our student’s safety and health are important to us.

**Parking Lot Policies:** Everyone is expected to follow and abide by the parking lot signs located on the property. Vehicles are to be parked in the large lot located south of the studio building. Do not park in the grass or on the sidewalks. Do not stop and park for long periods of time in the front area of the studio. This is to ensure the safety of our students and an orderly flow of traffic. EDC is not responsible or held liable for any accidents that occur in the parking lot and/or the property itself. Please make sure all trash from a vehicle is placed in the trash receptacle located on the north side of the building and NOT on the ground of the parking lot. The parking lot is not a playground, all children MUST be supervised while outside the building.

**Tobacco Free Campus:** EDC is a 100% tobacco free campus. We thank you for your cooperation.

**Inclement Weather Closing & Holiday Breaks:** When the studio closes due to inclement weather, closings will be posted on the studio website banner and studio Facebook page. Holiday breaks will be posted on the studio website, Facebook page, monthly newsletter, and the lobby bulletin board.

**Press:** Studio related press releases are required to be approved by the EDC director prior to being published.

**Studio Photos:** Any photos taken of students by EDC, Engelken Photography, or any other photographer hired by or representing EDC may be used for studio advertising, announcements, and website use.

**Online Parent Portal:** Look for updates, invoices, payment history, and more in your online parent portal.

**Studio Facebook:** Feel free to “Like” our Facebook page “Entertainment Dance Company” to view additional studio updates and reminders. This resource is utilized and updated frequently.

**Competitive Dance Team:** Competitive team auditions are set for Sunday, August 22, 2021. Student/Parent information meeting will be held on Wednesday, August 4<sup>th</sup> @ 6:30pm. See Facebook page or website for meeting schedule details. A student must have two full years of studio dance instruction for eligibility to audition, unless otherwise approved by the director. Students new to competitive dance who are interested in auditioning for a competitive spot need to contact the director as soon as possible. All updates and information pertaining to auditions can be found on the studio website and/or Facebook page.

**Summer Dance Activities:** The annual studio pool party, Valley Falls pool, will be held during the summer of 2022. EDC and the Valley Falls pool are not responsible or held liable for any injury sustained during the summer pool party event. EDC has an annual float in the Jefferson County 4-H Fair Parade. EDC, its staff, and the owner(s) of the truck and trailer are not liable for any injury sustained during parade events.

**COVID-19 and Variants:** EDC has put in place preventative measures to help reduce the spread of COVID-19 and variants. However, EDC cannot guarantee that your family and/or child(ren) will not become infected with COVID-19/Variants. By gathering together with other participants there is a potential to contract infectious communicable diseases such as, but not limited to, COVID-19/Variants.
